Grant funds are to be used to pay only salary and benefits up to \$50,000 per position, per year, including the required local cash matching funds. If awarded, we could expect the grantor to pay \$37,731 with a local match of \$12,269. The grant would be for a period of twelve months with a maximum length of award being four years.
