The Department of Community Development has received a request from Ms. Renée P. Williams, Superintendent of Schools, to waive permit and all other fees associated with power restoration to N.B. Clements Junior High School.

The total fees associated with the project are \$933.09, which includes a permit fee of \$598.09 and after-hours inspection fee of \$335.00. The general parameters and criteria that have been considered in the past when granting such requests include minimal financial or resource impact to the department, volunteers performing the work, donated materials, and/or County work forces performing the work. The value of the permit fee and the related costs of inspections are of minimal impact to the Community Development & Code Compliance department. This project does not meet any of other typical parameters usually considered for waivers or fee reductions.
