Resolution; Necessity for the Local Governing Body to endorse 2018 Smart Scale Transportation Candidate Projects

The third round of Smart Scale transportation applications are being accepted. The Commonwealth Transportation Board has made changes to the upcoming Smart Scale application process, including limiting the number of applications that can be submitted (for localities with population under 200,000) to four, requiring Board endorsement of the candidate projects, and accepting applications every other year as opposed to annually. The Commonwealth Transportation Board selects and funds transportation projects summitted through the Smart Scale application process by project priority. The application deadline is August 1, 2018.

Virginia Department of Transportation staff has prepared four (4) projects to increase safety in Prince George County to present for Smart Scale applications. The four (4) projects are listed below with their expected budget. Project 1 is currently a project listed in the VDOT Six-Year Improvement Program and could be completely funded by 2024 if the Smart Scale Application is funded.
