Subject: Route 10 Rumble Strip Installation

Dear Mr. Chairman and Board Members;

A study was performed by JMT for the rumble strips that Prince George County requested be installed along the majority of the two lane portion of Route 10 from 642 Beaver Castle Rd. to Route 610 Chippokes Rd./ county line. The work was to be installed with safety and operational funds.

The results of the study has determined that about 70% of the area is considered residential. For this study residential is considered Dwellings within 250' of Route 10 and dwellings of three or more within 1/4 mile of each other.

I will present this information to the Board at the July 10th meeting, and request clarification on how the Board would like to proceed. Since such a large portion of the zone is considered residential you essentially have 2 options.

- 1. Eliminate the request and only move forward with installation of the snow plowable markers/reflectors along the centerline.
- 2. Have mumble strips installed which are similar with a lower decibel noise reflected toward the homes. Keep in mind, these will still likely be heard by citizens depending on how close their home is to Route 10.

Neither rumble or mumble strips will not be installing either type in passing zones.

Please note: Both rumble and mumble strips are cut into the pavement and cannot be removed or paved over once installed.
