On September 12, 2017, the Board of Supervisors heard a presentation in worksession by Jeff Stoke, Carol Bowman and Michael Radtke, Riggs Ward, to develop an alcove display and bust to depict the life and history of Prince George of Denmark. Consensus of the Board to move forward with the project and not exceed \$116,400. Project is complete and funds for payment to be allocated to the Prince George Heritage Museum. The final total cost was for \$116,000 (\$400 less than original estimate).
