

**ACCEPTANCE OF THE DEDICATION OF VARIOUS
TEMPORARY DRAINAGE AND CONSTRUCTION
EASEMENTS IN BIRCHETT ESTATES AND CEDAR
CREEK FOR STORMWATER IMPROVEMENTS**

Since 2014, County residents have paid an annual stormwater fee of \$36 that is used to repair pre-existing water features in the County that collect and transport surface stormwater. Currently three large stream restoration/repair projects have been designed and construction will begin shortly in Birchett Estates and Cedar Creek. (See attached map.) In accordance with § 15.2-1803, Code of Virginia (1950), as amended, the Board must authorize the County Administrator to accept the dedications at no cost of the easements, located on the following properties.

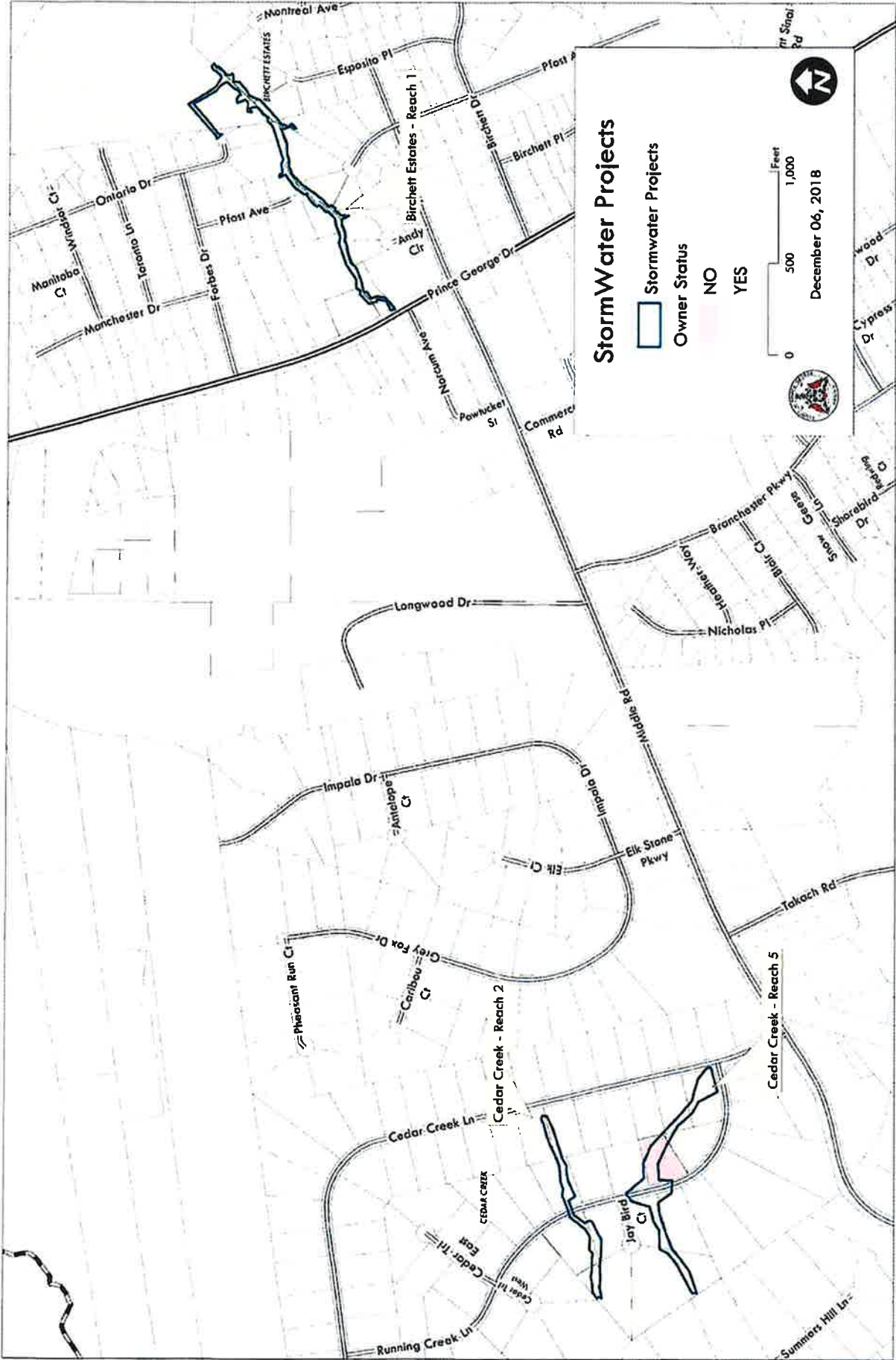

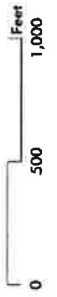
