Prince George County has received <i>Four for Life funds</i> in the amount of \$35,020.96 that have not yet been appropriated to the FY2019 budget. Four for Life funds are derived from an additional \$4.25 vehicle registration fee per year that is collected by DMV for each automobile and pick-up or panel truck. These collections are set aside as a special fund to be used for EMS purposes. This allocation represents 26% of collections that are returned to Prince George County based on the vehicles registered in Prince George County. Excerpts from a 2009 Virginia Department of Health presentation are attached to provide additional information on this funding source, allocation and the intended/approved use of funds.
