On February 22, 2019, Prince George County received notification from the VA ABC of the Proud Mamas Kitchen LLC ABC license application on February 21, 2019. Per state code, local governing bodies shall submit objections to the granting of a license within 30 days of the filing of the application. The Prince George County Board of Supervisors may recommend 1) approval, 2) denial, 3) approval with conditions, or 4) take no action. The Prince George County Board of Supervisors may submit any comments before March 23, 2019 to the Virginia Alcoholic Beverage Control Authority.
