TRAFFIC STUDIES/SPECIAL REQUESTS

- Request for speed limit reduction on Route 106 (Courthouse Rd.) from just before the Prince George VDOT Area Headquarters to just past the traffic circle on Courthouse Rd. The location is under review and will update County Board of Supervisors.
- Citizen is requesting that Route 626 (Tavern Rd.) be made into a "No Thru Truck" road. The location has been forwarded to Traffic Engineering for revised traffic count.
