Description and Current Status

On March 25, 2019, Prince George County received notification from the VA ABC of the Prince George Farms Inc (DBA: Sheetz #667) ABC license application. Per state code, local governing bodies shall submit objections to the granting of a license within 30 days of the filing of the application. The Prince George County Board of Supervisors may recommend to the VA ABC: 1) approval, 2) denial, 3) approval with conditions, or 4) take no action on the notice. The Prince George County Board of Supervisors may submit any comments before April 24, 2019 to the Virginia Alcoholic Beverage Control Authority. VA ABC has final authority on this matter.
