Description and Current Status

Prince George County participates in the Riverside Regional Jail and pays for Board and Care of Prisoners in that facility in accordance with a regional agreement. Prince George County has seen an increase in census above budgeted levels.

During quarterly financial updates, the Board has been made aware of this increase in census, and a resulting projected excess of actual expenditures over budgeted expenditures for FY2019.

The FY2019 budget for Board and Care of Prisoners is \$1,354,894. Expenditures for monthly billings between July 2018 and April 2019 total \$1,576,520. May and June 2019 invoices are pending and are expected to total over \$315,000. Total FY2019 expenditures are estimated to be nearly \$1,900,000. A deficit of between \$530,000 and \$540,000 is projected for FY2019.
