Description and Current Status

The CSA program is mandated by the State of Virginia to provide high quality, child centered, family focused, cost effective, community-based services to high-risk youth and their families. The mix of services that the County provides typically yields a 62.84% reimbursement from the state and 37.16% local match.

The budget established for FY18-19 expenditures was \$1,260,000. For the Fiscal Year ended June 30, 2019, CSA has committed funds in excess of the expenditures allotted. The CSA coordinator is now projecting total expenditures of \$2,240,353 (estimated in June 2019 at \$2,209,325). This represents a budget shortfall of \$980,353 over the original CSA budget of \$1,260,000. The CSA coordinator is requesting an additional state supplement in the amount of \$31,028; of which, the State portion is \$19,498 [62.84% of the shortfall]. The supplement requires a 37.16% match from the locality, which equates to \$11,530.

This deficiency requires an appropriation from the General Fund's Fund Balance.
