Description and Current Status

The CSA program is mandated by the State of Virginia to provide high quality, child centered, family focused, cost effective, community-based services to high-risk youth and their families. The mix of services that the County provides typically yields a 62.84% reimbursement from the state and 37.16% local match.

The budget established for FY19-20 expenditures was \$1,950,000. For the Fiscal Year ended June 30, 2020, CSA has committed funds in excess of the expenditures allotted. The CSA coordinator is projecting total expenditures of \$2,262,438. This represents a budget shortfall of \$312,438. The CSA coordinator is requesting a state supplement in the amount of \$196,336 (62.84% of the shortfall). The supplement requires a 37.16% match from the locality, which equates to \$116,102.

This deficiency requires an appropriation from the General Fund's Fund Balance.

Board Action Requested: A Draft budget amendment / appropriation and transfer from General Fund's Fund Balance is attached for Board consideration.
