### **Description and Current Status**

The Route 460 (County Drive) water line extension project requires the acquisition of permanent utility easements on 14 parcels. In addition, several parcels require temporary construction easements for the installation of the water line within the Route 460 right-of-way. The easement widths vary for each parcel based on the location of the water main along County Drive.

These easements allow for the installation and maintenance of the new water line along County Drive. A chart showing each of the 14 parcels including the tax map number and owner information is attached hereto.

**Board Action Requested:** Resolution accepting the Deed of Easements for each of the 14 parcels to allow for the installation and continued maintenance of a water line.

# **Fiscal Impact Statement**

The acquisition of each easement includes compensation for each impacted parcel owner. Each parcel will receive 30% of the market land value for a permanent utility easement and 10% for a temporary construction easement. Damages to structures and trees on each property will also be compensated. It is anticipated the total cost to obtain the easements for the water line extension project will be \$12,174.

# **County Impact**

Acceptance of the easements will allow for the construction of the new water main to meet the fire flow demands of the Southpoint Business Park and and will allow for the abandonment of the well foref the Food Lion water system by connecting it to the Central system supplied by the Appomattox River Water Authority.
