### **Description and Current Status**

On August 17, 2020 the Prince George County Registrar received notice of an award of CARES ACT funding in the amount of \$58,910. The Board of Supervisors provided email approval for Mr. Ashcraft and Mr. Richeson to sign the required certification to receive these funds. The certification was submitted as required on August 18, 2020.

Finance staff and the Registrar developed a plan to expend these funds for the upcoming presidential election in November 2020.

Department 0919 was established within the General Fund to separately track expenditures for this CARES ACT funding. The funds will be used to pay for:

- > Additional compensation for officers of election, part-time staff and overtime for full-time staff (related to work surrounding increased volume of absentee ballots)
- > Postage for distribution of absentee ballots
- > Additional ballots and supplies

**Board Action Requested:** Approve budget amendment / increase in General Fund revenues and expenditures. A Draft budget amendment / appropriation is attached for Board consideration.
