Description and Current Status

The Police Chief received board permission to apply for a FEMA Port Authority grant to purchase twin outboard motors for the current police marine vessel on April 14, 2020 (grant application amount was \$50,000, with a local match not to exceed \$12,500). See resolution R-20-038 as **Attachment A**.

We received notification of a **grant award in the amount of \$29,600, with a local match requirement of \$9,867 (25%)**. The award notice is attached for your review (**Attachment B**). The grant period September 1, 2020 – August 31, 2023.

The **recommended source for the 25% local match of \$9,867 is a transfer from the General Fund Contingency**.

WHEREAS, the Police Department is requesting approval of the Prince George County Board of Supervisors to apply for a grant to purchase new, twin, Mercury, 200hp, outboard motors for the current police marine vessel; and

WHEREAS, the total award is not to exceed \$50,000 with a local match no more than \$12,500; and

WHEREAS, the current marine vessel is a 2005, commercial grade, 24' Boston Whaler powered by twin, mercury outboard motors and the motors are original to the 15-year old vessel; and

WHEREAS, the need to re-power the marine vessel is recommended, regardless of grant opportunity.

NOW, THEREFORE, BE IT RESOLVED That the Board of Supervisors of the County of Prince George this 14th day of April, 2020, does hereby authorize the submission of a grant application to the Virginia Port Authority for a grant not to exceed \$50,000, which requires a local match of \$12,500 from General Fund contingency or

Article I - Summary Description of Award

The terms of the approved Investment Justification(s) and Budget Detail Worksheet(s) submitted by the recipient are incorporated into the terms of this Federal award, subject to the additional description and limitations stated in this Agreement Article and the limitations stated in subsequent reviews by FEMA of the award budget. Investments not listed in this Agreement Article are not approved for funding under this award.

Investment 1: Emergency response vessel repower investment is fully funded for \$29600.

Article II - Activities Conducted Abroad

Recipients must ensure that project activities carried on outside the United States are coordinated as necessary with appropriate government authorities and that appropriate licenses, permits, or approvals are obtained.

Article III - Reporting of Matters Related to Recipient Integrity and Performance

If the total value of any currently active grants, cooperative agreements, and procurement contracts from all federal awarding agencies exceeds \$10,000,000 for any period of time during the period of performance of this federal award, then the recipients must comply with the requirements set forth in the government-wide Award Term and Condition for Recipient Integrity and Performance Matters located at 2 C.F.R.
