An Invitation for Bid (IFB) for routine and emergency repair annual services contract was issued on January 25, 2021, and closed on February 11, 2021. Work under this contract includes the maintenance, repair, and minor construction of water lines, sewer lines, manholes and associated appurtenances. This is the second IFB for this work to have at least two contractors available to perform emergency work.

One response was received, which was from Ellis Construction, Inc. The bid was reviewed by staff and is considered a responsive and responsible bid.

The term is for a one-year period. This contract may be renewed by the County for four (4) years at successive one-year periods under the terms and conditions of the original contract. This contract will be effective on April 1, 2021.

Staff recommends an award of the annual services contracts for routine and emergency repairs to Ellis Construction, Inc. in accordance with the terms and conditions provided for in IFB #21-11-0600.
