### **Description and Current Status**

We received insurance proceeds from VACORP for damages related to a 2020 Ford Explorer Interceptor (Police Department; VIN 1079). The vehicle was damaged on July 15, 2021 when the Police vehicle struck a building while backing out of a driveway after responding to a call. The vehicle sustained damage to the rear driver's side. The estimated repairs for the vehicle were \$5,680.40, and the amount received is \$5,180.40 (repair estimate, less \$500 deductible).
