## **Description and Current Status**

The amount of funding to be provided for Southside Programs for Adult Continuing Education (SPACE) for each fiscal year is determined *following* the beginning of each fiscal year. The Board of Supervisors adopts a preliminary budget with the understanding that once state revenues are known, revisions will be submitted. The County has received notice through SPACE that final awards and reallocations are \$41,457.23 more than amounts currently reflected in Munis / Adopted amounts.

The requested appropriation increases are the amounts above those included in the adopted FY2022 budget.

Full details of the revenue and expenditure changes are provided on **Attachment 1**. Communications from the state are provided on **Attachment 2**.

## **Fiscal Impact Statement**

Adult Education operations do not have a fiscal impact on the County. The activities are housed in a special revenue fund (Fund 0218) and all expenditure operations are supported by revenues within that fund.

A \$41,457.23 increase in appropriation is required in order for regional Southside Programs for Adult Continuing Education (SPACE) to expend the higher estimated revenues.
