Description and Current Status

Hopewell/Prince George Fraternal Order Of Police own 6.0 acres of property located on Middle Road known and designated as Tax Map # 13A(03)00-00B-0. Owner wishes to sell such property.

Prince George County wishes to purchase such property for the future expansion of the public utility and has entered into negotiations for the purchase of the property. The County will have 60 days to study the property. Closing on the property will take place 30 days after the end of the study period.

The County and seller have agreed to a purchase price of \$80,000. There is an estimate of approximately \$3,000 for closing cost.

\$80,000 is available from Utilities Reserve Fund, Fund Balance

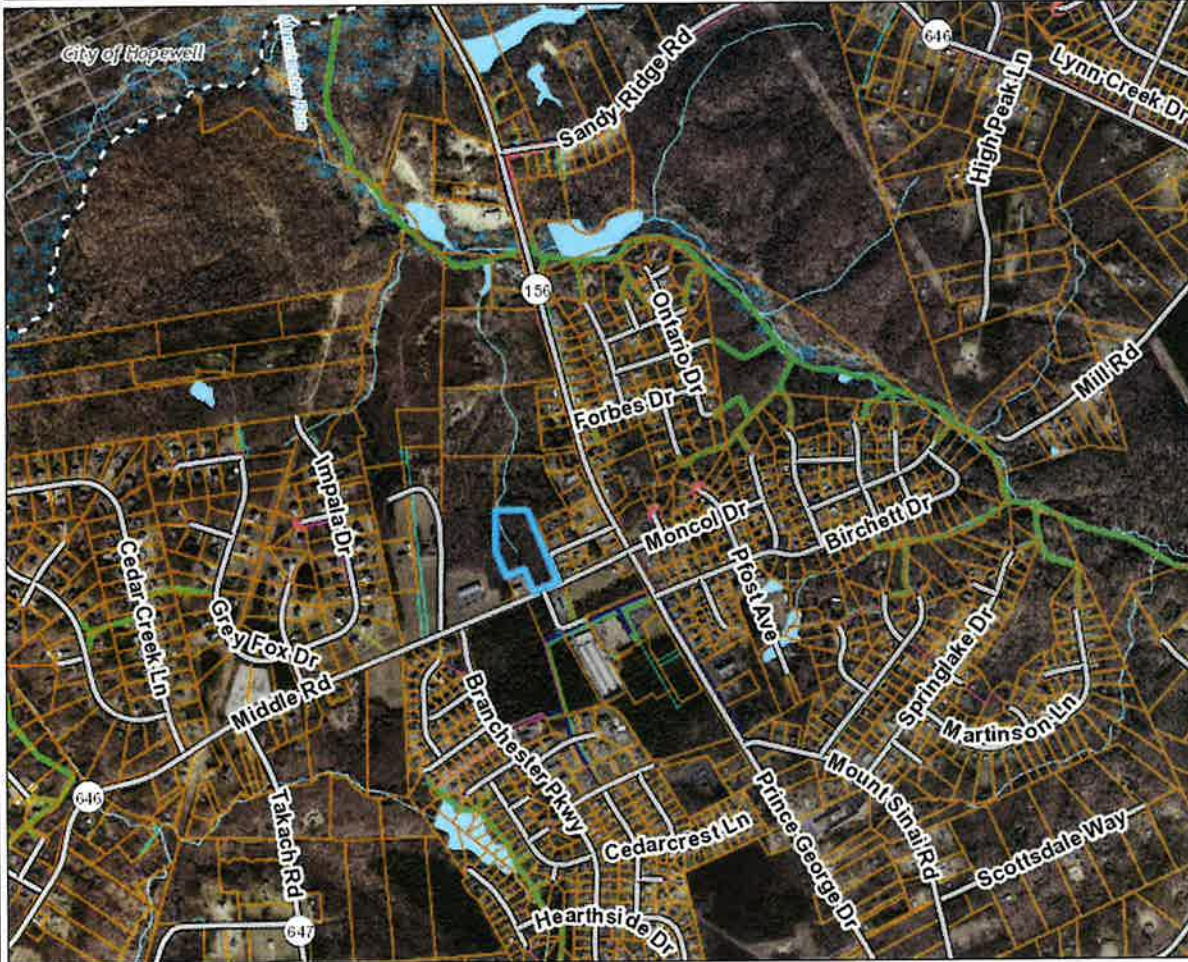

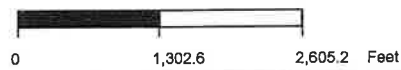
