## Description and Current Status

The GIS Coordinator has received a request to change the name of Bey Jones Lane to Jones Meadow Lane. GIS shows three property owners with legal access. (See attached map) Only one property owner has an assigned address of Bey Jones Lane. The other properties are owned by Latasha West-Bey, and William H. Jones.

The three property owners are in agreement to change the street name from Bey Jones Lane to Jones Meadow Lane. I have attached a signed agreement from the property owners.

Pursuant to County Code Section 63-72 the following travelways shall be named: (1) all roads proposed for acceptance in the state road system; (2) right of way or access easements intended to serve three or more addressable structures; and (3) any other travelway which the GIS Coordinator determines should be named to promote safety and welfare to the public.

A motion approving a Resolution changing the name of Bey Jones Lane to Jones Meadow Lane is requested.
