Re: CIP Budget Transfer, Playground Upgrade Project Budget to Central Wellness Center

Maintenance Budget; \$10,617.78

As part of the FY2017 adopted budget, the Board approved a \$70,000 General Fund Transfer to CIP to cover expected costs of two Community Playground Upgrades [River's Edge & Stratford Woods]. Actual expenditures amounted to less than \$70,000 and an *unexpended balance of* \$10,617.78 remains in that capital budget code.

As part of adding a gym to the Central Wellness Center, a number of repairs have been made to the old Library and office area. The remaining amount in the CIP Central Wellness Center Repair budget is \$14,112.88 currently. In order to get the fitness room and office ready, a number of improvements and purchases are still pending / yet to be made to include:
