## **Description and Current Status**

The Economic Development and Tourism Department is requesting approval of the Resolution accepting the Tourism Agreement between participating localities such as City of Hopewell, Virginia, Hopewell Downtown Partnership, Prince George County, Virginia, James City County, Virginia, Surry County, Virginia, and Charles City County, Virginia.

# RESOLUTION ACCEPTING THE TOURISM AGREEMENT BETWEEN THE COUNTY OF PRINCE GEORGE AND PARTICIPATING LOCALILITIES

WHEREAS, the Tourism Agreement is among the City of Hopewell, Virginia, Hopewell Downtown Partnership, Prince George County, Virginia, James City County, Virginia, Surry County, Virginia, and Charles City County, Virginia, and all of which are hereinafter referred to as "Participating Localities," and

WHEREAS, the Tourism Agreement will establish marketing and itineraries for visitors to explore the 5 & Dime Trail connecting Participating Localities, and


WHEREAS, the formation of this trail creates a vehicle to market businesses and assets together as a tourism destination, and

**WHEREAS**, the Participating Localities seek to pool their financial resources to promote local attractions and food and beverage along the 5 and Dime Trail throughout each of their respective jurisdictions; and

**NOW, THEREFORE, BE IT RESOLVED,** that the Prince George County Board of Supervisors accepts the Tourism Agreement on February 14, 2023 and that the County Administrator is directed to execute the Tourism Agreement between the Participating Localities.

#### **TOURISM AGREEMENT**

THIS TOURISM AGREEMENT is made and entered into this 31st day of January, 2023, by and among the CITY OF HOPEWELL, VIRGINIA ("Hopewell"), Hopewell Downtown Partnership ("HDP"), Prince George County, VIRGINIA ("Prince George"), James City County, VIRGINIA ("James City"), SURRY COUNTY, VIRGINIA ("Surry"), Charles City County, VIRGINIA ("Charles City"), each of which is hereinafter referred to as a "Participating Locality", and all of which are hereinafter referred to as "Participating Locality".

#### WITNESSETH:

WHEREAS, the Participating Localities seek to pool their financial resources to promote local attractions and dining/beverages along the "5 and Dime Trail" throughout each of their respective jurisdictions; and

WHEREAS, the Participating Localities wish to set forth the basic parameters of their relationship in said endeavor as more specifically set forth herein,

Now, THEREFORE, in consideration of the promises and covenants set forth herein, the Participating Localities agree as follows:

- 1. TERM: The initial term of this Agreement shall be for a period commencing on the date the last Participating Locality execute this Agreement and shall terminate on December 31, 2027. This Agreement shall automatically renew for two (2) additional five-year terms ("Renewal Terms") unless otherwise terminated as more specifically set forth herein.
- 2. FINANCIAL COMMITMENT: Each Participating Locality shall commit at least One Thousand Five Hundred Dollars (\$1,500.00) from the respective tourism budgets for each fiscal year to further advance and finance promotional efforts to support local cuisine and dining throughout their respective jurisdictions.
- 3. FISCAL AGENT: Hopewell Downtown Partnership 501 c3 shall operate as the Fiscal Agent and shall have custody of all funds collected for the purposes set forth in this Agreement and shall continue to serve in such a capacity unless and until otherwise agreed to by the Participating Localities. Each Participating Locality shall be billed by the Fiscal Agent on a fiscal year basis. Payment from the Participating Localities shall be made within thirty (30) days of receipt of said bill. Failure to pay within thirty (30) days of receipt shall result in a 5% interest payment for late payment.
- 4. TERMINATION: A Participating Locality may terminate their participation in this Agreement for future years with sixty (60) days written notice to the Fiscal Agent prior to the end of the fiscal year or upon non-appropriation of funds pursuant to Paragraph 7.
- 5. SEVERABILITY: Each provision of this Agreement shall be separately enforceable, and the invalidity of one provision shall not affect the validity or enforceability of any other provisions. This Agreement shall be interpreted and construed in accordance with the laws of the Commonwealth of Virginia.
- 6. ENTIRE AGREEMENT: This Agreement constitutes the only agreement, and supersedes all prior agreements and understandings, both written and oral, among the parties with respect to the

subject matter hereof. This Agreement may not be amended or modified, except in a writing signed by all parties to this Agreement.

7. NON-APPROPRIATION: It is understood and agreed between the Participating Localities that they shall be bound and obligated to the amount set out in Paragraph 2 only to the extent that the funds shall have been appropriated and budgeted for the purpose of this Agreement. In the event funds are not appropriated and budgeted in any fiscal year for payments due under this Agreement by a Participating Locality, such locality shall immediately notify the Fiscal Agent and their participation in this Agreement shall terminate on the last day of the fiscal year for which an appropriation was received without penalty or expense to the Participating Locality of any kind whatsoever.
