WORK SESSION

Chairman Robertson made some opening remarks.

Mr. Ashcraft gave a formal PowerPoint presentation on the agenda listed below which highlights the County Administrator's proposed FY17 budget.

Discussion of Certain Expenditures

- a. Education proposed MOU to the School Division is \$15,764,879 and school bus purchases in the amount of \$800,000.
- b. Human Resources proposed two new positions: Economic Development Specialist (full time) and Assistant County Attorney (part time). There are also some reclassifications and salary adjustments in several departments. The Social Services Department forced to change several employees from Exempt to Non-Exempt due to Department of Labor federal ruling. Health Insurance projected increase of 10%.
- c. Equipment paid by the General Fund Sheriff's Software, Vehicle Replacement, Playground Upgrades, and the school buses previously discussed.
- d. Discussion of CSA local match increase of \$76,120. Reduction of requested contribution to Riverside Regional Jail and Crater Youth Care of \$425,971.

Revenues

- a. Reductions from FY16 a chart was presented listing the adjusted line items in the proposed budget to reflect realistic budget estimates.
- b. Increases from FY16 a chart was presented listing the adjusted line items in the proposed budget to reflect projected increases.

One Time Revenue Sources

The sale of the former Carson VFD, a contribution from Dinwiddie County and a one-time capital contribution from Dinwiddie County for the new Carson VFD are proposed.

Discussion of Fund Balance

The proposed FY17 fund balance will be \$13,600,000. This would be 12.7% of the expenditures and within the minimum policy set by the Board of Supervisors.

Other Matters

Future budget work sessions will have specific budget discussions. There will be future health insurance and CIP discussion.

Consensus by the Board of Supervisors to remove the Timber Exemption as a potential revenue source. Difference will have to be made up by other means.

Consensus by the Board of Supervisors to prepare the real property tax rate advertisement but, leave the number blank for the meeting on March 8th.

The Chairman requested Police staff salary information at the next budget work session meeting. Other possible departments to speak in the future include Fire/EMS and Sheriff's Office.

Chairman spoke about the following possible departments to discuss budget requests: Community Development, General Properties, Animal Control and Parks & Recreation. The next Board of Supervisors budget work session will be March 10th at 6pm.

PRESENTATIONS

SUPERVISORS' COMMENTS

Mr. Skalsky stated that he is grateful that the tornadoes did not do any real damage in Prince George County. He added that his thoughts and prayers go out to the people in Waverly.

Mr. Webb echoed Mr. Skalsky's comments regarding the tornadoes.

Chairman Robertson reminded everyone of the Culinary Arts event currently going on in Fort Lee and encouraged everyone to attend.

COUNTY ADMINISTRATOR COMMENTS

Mr. Ashcraft stated that the Perdue Community Luncheon will be on March 9 at 11 a.m. at Perdue Farms, Inc. at 5155 Chudoba Parkway. The Knights of Columbus 'Lenten Fish Fry' will be on March 11 from 5 to 7 p.m. at the Church of the Sacred Heart. There will be a Spaghetti Dinner on March 12 from 4 to 8 p.m. at the Prince George Volunteer Fire Department. The Carson Volunteer Fire Department Oyster Roast will be on March 12 from 3 to 6 p.m. at the Rives Ruritan Club. The Prince George Promise Youth Awards Ceremony will be on March 15 at 7 p.m. at the Prince George High School. The United Way Meeting & Awards Program will be on March 16 at 11:30 a.m. at the John Randolph Foundation. 'Ladies First: The Contributions of Women Throughout History:' will be on March 20 at 2 p.m. at the Heritage Center. The new Carson Volunteer Fire Station is about 95 percent complete; dedication is May 15 at 3

p.m. Sidewalk construction & lighting continues at Exit 45. The Department of Environmental Quality (DEQ) has awarded Prince George County a \$178,750 grant for stormwater improvements at Cedar Creek subdivision. Registration for Prince George Summer 4-H Camp began February 1. Luther Hester has replaced Barbara Tabb on the Prince George County Electoral Board. The new Tourism Guide is now available to the public. The Public School Division is reaching out to community with a comprehensive survey. Voter turnout for the March 1 Presidential Primary Election was 30.2 percent. The Prince George Journal announced March 6 it will discontinue publishing after 20 years. The new website is to be launched the week of March 21. There will be a swearing-in for the new Chief of Police on March 14 at 9:30 a.m. in the Circuit Court Courtroom.

REPORTS

Virginia Department of Transportation – Ms. Crystal Smith of the Virginia Department of Transportation stated that they received 160 work requests last month and there are currently seven vacancies at the Prince George area headquarters. They are looking to recruit some of the students out of the Rowanty area. Crews are focusing mainly on potholes, shoulder work, tree trimming, and pipe cleanouts at this time. They are looking at Courtland and Templeton Roads for a speed reduction. A request for a roundabout study at Courthouse Road and Bull Hill Road is under review. The intersection is also being reviewed for safety measures that can be implemented. There has been work done on the Route 10, Middle Road, Jefferson Park Road, and Ruffin Road shoulders. They collected 36 bags of trash off of Brandywine Road. The potholes in Rolling Meadows have been addressed. There will be additional pothole work done on Route 10 next week. The Route 460 work at the Harvanek property is moving forward. However, they have not been able to work out an agreement with the property owner. Mr. Hunter asked Ms. Smith to have the manhole covers checked in Rolling Meadows. Chairman Robertson asked Ms. Smith to repair the asphalt on Temple Avenue where it is coming up.

Baxter Road Sewer Rehabilitation – Mr. Chip England, County Engineer, gave a brief update on the status of the Baxter Road Sewer Rehab Project. He stated that the on-site construction activities are scheduled to begin the second week in April and will last into June. The contract is with Insituform in the amount of \$977,644. Work will be done during the week days and some weekends during this period. The work will involve shoulder closures on Courthouse Road between Bull Hill Road and Baxter Road, and closure of one lane on Baxter Road. Customers along Baxter Road and Partridge Court will be given at least 48 hours' notice and will be without services for about 12 hours. Notices will be posted to the County website and social media, newspapers, roadside message board, and VDOT traffic update channels.

PUBLIC HEARINGS

P-1. Public Hearing; Middle Road Lease Agreement. Mr. Steve Micas, County Attorney, stated that in 1997, the County acquired 75.01 acres on Middle Road (TM 12-(7)-A) for a possible school site. In 1998, the County leased what was thought to

be 21.69 acres of cleared land within the 75.01 acres to Spencer B. West for \$500 a year. The leased property has been used for pasture land and also contains a County water tank and communications tower. Even though the lease technically expired a number of years ago, Mr. West has continued to pay the annual rent and uses the property for pasture land. If the Board wants to continue leasing the property, the Assessor has indicated that agricultural acreage with this type of soil has an annual lease value of \$50/acre or \$1,000.00 per year for the portion of the Middle Road parcel used by Mr. West which is closer to 20.00 acres. Staff recommends a five-year lease. In order to lease real estate owned by the County, the Board must hold a public hearing pursuant to § 15.2-1800 Code of Virginia, 1950, as amended. Chairman Robertson opened the public hearing at 7:34 p.m. There was no one to speak and the public hearing was closed. Mr. Skalsky stated that he thinks \$50 is too much. Mr. Hunter added that Mr. West has been a good steward of the property. The Board asked Mr. West if he would be agreeable to \$600 a year. Mr. West stated that would be fair. Mr. Hunter made a motion, seconded by Mr. Carmichael to approve the lease agreement in the amount of \$600 a year. Roll was called on the motion.

ORDER OF BUSINESS

A-1. Resolution; Authority to Advertise a Public Hearing for Certain Tax Rates.

Ms. Betsy Drewry, Finance Director, stated that the County Administrator proposed the Fiscal Year 2016-2017 budget at the February 23rd board meeting and called for a \$0.04 increase in the Real Estate Rate and no change in other established tax rates. As the tax rates of the County are set by resolution, the setting of the tax rate requires a public hearing. The Personal Property tax rates are required to be adopted by April 15th in order for the Commissioner of Revenue and the Treasurer's Office to print the tax bills and have them mailed by April 25th for the June 6th collection date. The tax rate proposed for Personal Property is \$4.25, the same as FY16. Mr. Carmichael stated that since the proposed Timber Tax was eliminated, the tax rate may need to be increased by \$.06. He also stated that no one wants to have their taxes raised so if they are, we need to show the citizens what that money will be used for. Mr. Webb stated that he is not in agreement for any tax rate increase, but unfortunately they may be pushed to have one because the general fund was lowered and there are bills to pay even though not everyone has agreed with the spending. He stated that they must figure out what services they need to supply and if the citizens want all the services, they need to know up front what it is going to cost. Chairman Robertson stated that in thirteen years he has never voted for a tax increase. However, he is going to vote for one this year for the simple fact that a little over \$1 million was used last year out of savings to keep from raising taxes. He and Mr. Hunter expressed a concern about the School Board's needs as well. Mr. Skalsky stated that sooner or later expenses catch up with you and that time has come. He too is in agreement with a \$.04 tax increase. Mr. Carmichael made a motion, seconded by Mr. Hunter to authorize a public hearing for a tax rate of \$.88 for real property at the hope that they will only need to increase it to \$.86. They can go below the advertised rate; they just cannot go above it. Roll was called on the motion.

WORK SESSION

County Administrator Percy Ashcraft opened the work session and Ms. Betsy Drewry, Finance Director, gave an update on the recently passed Virginia General Assembly budget. Ms. Drewry gave an update on reduced County costs for the VRS program. Mr.

Ashcraft gave an overview of the FY17 vehicle replacement program and Mr. Hamby was asked to prepare a list of mileage for the vehicles under consideration for replacement. Chairman Robertson requested a list of all county vehicles with mileage and year.

Commissioner of Revenue Darlene Rowsey is requesting in the FY17 budget a new employee for October 2016 to learn on the job for five months until the retirement date of the current tax compliance auditor on March 1, 2017. The total impact to the FY17 budget would be \$28,684.

Keith Rotzoll, Director of Parks and Recreation, discussed the highlights of the Parks and Recreation budget proposal. Ms. Drewry addressed the salary line item questions. The increase in the part-time position line item is primarily for the new Central Wellness Center staff and temporary summer staff. Mr. Rotzoll explained that the County is preparing for many ball tournaments this summer and a large ASA U14 Eastern Regional softball tournament July 31-August 4.

Interim Chief Eric Young discussed the selective enforcement line item reduction due to undermanned staff. Chief Young reviewed the current staffing status. Chief Young is requesting two additional officers — K-9 Officer and Community Policing Officer. Chief Young discussed police involvement in community events. Chief Young discussed a proposed career development program that is not currently included in the FY17 budget. There was discussion with the Board regarding supplies and equipment for the Police Department, Emergency Communications Center and Animal Control. There was discussion on the current roles of the part-time officers.

Bill Hamby, Director of General Services, gave an overview of the Landfill, Garage and General Properties proposed budgets. There was discussion on the interdepartmental charge back for labor during vehicle servicing. Mr. Hamby reviewed the key new items within the General Properties budget. Mr. Hamby reviewed the increases in utility costs for County facilities.

Mr. Ashcraft explained that the next budget work session will be held Monday, March 14 at 6pm at the Community Room in the Health and Human Services Building. Departments for the next meeting include Fire/EMS and Social Services. For Board consideration, Ms. Drewry discussed various scenarios for County employee raises and bonuses at different levels. It is anticipated that the school system could budget for a 3% employee raise due to 2% coming from state funds.

Sheriff Bucky Allin addressed the selective enforcement line item in the proposed budget. There was discussion on the requested CivilServe software and tablet purchases proposed in the FY17 budget.

ADJOURNMENT. Mr. Webb made a motion, seconded by Mr. Hunter, that the meeting adjourn at 8:40 p.m.
